## **Attention to all students**

**Summary** of possible punishments for students involved in gagging activities (any one Or any combination of the following)

- 1. Cancellation of admission.
- 2. Suspension from attending classes.
- 3. Withholding/Withdrawing scholarship/fellowship and other benefits.
- 4. Debarring from appearing in any test/examination or other evaluation process.
- 5. Withholding results.
- 6. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc....
- 7. Suspension/expulsion from the hostel.
- 8. Rustication from the institution for period ranging from 1 to 8semesyers.
- 9. Expulsion from the institution and consequent debarring from admission to any other institution.
- Collective punishment: When the persons committing or abetting the crime of Ragging are not Identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure of the potential raggers.
